OUR MISSION

The Ridgefield School District will develop well-rounded students who have the capacity to succeed in a technologically driven global society. The District will continue to create and sustain a safe and caring learning environment in which all students will meet or exceed state standards. The District will engage the community in school issues and seek community input in decision making.

THE MEETING...

Our meetings are open to the public and all our discussion will be held during an open meeting with the exception of "executive session." As you will note, there is time on the agenda for citizen comments and questions during Audience Participation. If you have questions about the specific procedure, please check with one of the board members or a district staff member prior to the meeting. Involved and informed parents and community members are our best guarantee of excellence in our public schools.

Regular meetings of the Board are held at 5:00 p.m. on the second and fourth Tuesday. Meetings are held at the Ridgefield High School Library. When there is a change in time, date or place, public notice is given through the news media.

All regular and special Board meetings are open to the public, and all actions authorized or required by law are taken at these meetings. The Board may, however, meet in closed (executive) session for the purposes of:

- Acquisition of Real Property
- Offering to Sell Real Property
- Publicly Bid Contracts
- Complaints or Charges Against an Employee
- Qualification of an Applicant or Performance of an Employee

- Qualifications of a Candidate
- Discussions with Legal Counsel

All formal actions are taken in public sessions. Minutes of all regular and special Board meetings are matters of public record.

The Board President and the superintendent are responsible for setting the agenda. The Board President conducts the meeting and is the spokesperson for the Board. Board meetings are meetings in which the Board conducts its business in public. The Board meetings are not meetings of the public. Questions may be communicated prior to the meetings.

THE AGENDA...

Ridgefield School District board members receive a full agenda several days prior to the meeting. The agenda may deal with a wide range of issues such as curriculum, budget, hiring of personnel, facilities, school transportation, or long range planning. The agenda usually includes written supporting material that helps with decision making. If it appears that we take a quick action on an item, it may be because we have been studying the topic for several weeks or that we have had our questions answered in advance of the meeting.

The members of the Board of Ridgefield School District are elected officials who:

- Establish policies that direct the district
- Employ and evaluate the superintendent
- Negotiate with employee groups
- Approve the annual budget
- Authorize elections regarding our schools
- Determine long-range direction for the district
- Communicate with the community
